Electric Motors

General Information

- ✓ No other Columbus Electric Cooperative energy efficiency credit of special rate or discount shall apply.
- ✓ Rebate must be requested within 90 days of purchase
- ✓ Must be a CEC active Member

Efficiency Standards

Incentive for Commercial and Industrial Motors

\$8 per Horsepower (hp).

Wiring assistance for electric irrigation motors that replace a fossil-fuel engine or new installation \$1.50/hp

Consumer must certify that the motor is new and neither re-wound or moved from another location

Incentive for Variable Speed Drive Retrofit

New and retrofit application

Rebate will be the lower of: 50% of the cost of the VSD unit or have a project cap of \$20,000

Rebate Requirements

Must provide proof of purchase (*itemized receipt or invoice*) for motor or specification sheet indicating horsepower of the motor. Receipt(s) must be legible and clearly show detailed product make and model information.

- ✓ Motors must be **new** and a minimum of 10 horsepower.
- ✓ For VSD retrofit- if a new motor is installed at the same time, it may qualify for a separate motor rebate.
- ✓ Replacement of existing VSD's, for maintenance or other purposes does not qualify.
- ✓ For VSD retrofit- soft start kits added to existing motors are not eligible for rebate
