**General Information**

- ✓ No other Columbus Electric Cooperative energy efficiency credit of special rate or discount shall apply.
- ✓ Rebate must be requested within 90 days of purchase
- ✓ Must be a CEC active Member

**Efficiency Standards**

All outdoor power equipment and electric bicycles must be new with a minimum purchase amount of \$50.00. See below for incentive amounts and general information about each item.

**Rebate requirements**

- ✓ Itemized receipt (*proof of purchase*) is required for each item. Receipts(s) must be legible and clearly show product make and model information.
- ✓ Other than electric bicycles, members are limited to one rebate per product type per year.
- ✓ New battery or corded equipment qualifies for a rebate. Battery chargers do not qualify.
- ✓ A maximum of \$300 per member account applies to listed equipment except riding lawnmowers. (stand-alone \$1000 cap per member account)
- ✓ Additional batteries purchased with and for qualifying equipment can be included with original purchase rebate application (one additional battery per product limit). Replacement battery-only purchases **are not eligible**. Multi-piece equipment combinations are eligible for individual rebate amounts provided \$50 cost minimum is met
- ✓ Additional battery rebates will be considered in multi-piece combinations if the number of batteries exceeds the number of products.
- ✓ Battery chargers do not qualify for any incentives.
